BYLAW No. 02-2019

A BYLAW TO AUTHORIZE A SPECIAL TAX FOR WASTE COLLECTION

The Council of the Town of Radisson, in the Province of Saskatchewan, enacts as follows:

1. A Special Tax be levied against all benefiting lands, as per Appendix A, for the service of Contracted Waste Collection Services to be completed within the year 2019.
2. The placing of Contracted waste collection Services is hereby authorized:

from January 1, 2019 to December 31, 2019;

within the Town of Radisson Limits.
3. The estimated cost of the Waste Collection Services for residential carts is \$ 20/month plus applicable taxes and fuel surcharge, estimated cost for commercial dumpsters for 4-yard dumpsters - \$ 239.00/month and 6-yard dumpsters is \$280.00/month.
4. The tax rate is \$ 20.00 per month per parcel of land to be levied against all owners/renters of land that are residential and commercial that require waste collection services and or \$ 20.00/month/container based on number of containers required others as per appendix A.
5. Any person who considers that an error or omission was made in the application or calculation of the special tax on his or her property may notify the municipality in writing by May 1, 2019 requesting the council to review the application or calculation of the tax rate regarding the property in question.
6. The administrator will notify the persons, who have requested a review, of the time and date the council will meet to hear and review the requests.
7. The taxes that are levied will be added to the water & sewer roll as a special assessment against the property, when they become due and payable, and are recoverable in the same manner as other taxes.
