WATER BILLING

PLEASE NOTE THE FOLLOWING CHANGES TO WATER BILLING THAT IS NOW IN EFFECT:

- Water bills are due in the month they are billed – Ex: Oct-Dec Bill – Sent January 9, 2020 is due by January 31, 2020
- Interest Penalty is now applied – unpaid account balances will be subject to 5% penalty at the end of each month until paid.
- Accounts in arrears after sixty-one (61) days of the billing date will have services discontinued. Reconnection will be done once account is cleared and a \$50.00 reconnection fee is paid
- Meters will be read twice a year – March and September

WINTER IS HERE!

To help Maintenance Staff with snow clearing, Council asks that all residents ensure that they park off street whenever possible and refrain from clearing their sidewalks and driveways into the street. Also, removing your waste and recycle carts off the street immediately after pick up would be greatly appreciated

CHARITABLE DONATIONS

In compliance with Canada Revenue Agency regulations for the issuance of donations receipts by qualified Donees, Council has adopted a Charitable Donation Policy which can be found on the Town Website. Some of the changes include the following:

Donations to the Radisson Recreation Board, Radisson Curling Club and Radisson Volunteer Fire Department:

- Donations shall be made in the name of the organization and submitted directly to the organization for deposit to their own accounts.
Donations to the Radisson First Responders and the Radisson Cemetery Committee:

- Donations are to be made payable to the Town of Radisson for allocation

Please note: Prior to January 31st each year, the Town of Radisson shall issue each Donor a Donation Receipt for the total donations made in the year prior

Donations to the Radisson Communiplex:

- Donations shall be made in the name of the organization and submitted directly to the organization for deposit to their own accounts.
- The Radisson Communiplex are a Qualified Donee and are qualified to issue Charitable Donation Receipts on their own behalf.

Donations to the Library must be made directly to them and the Town is not able to issue donation receipt.
