BYLAW 2022-4

A BYLAW OF THE TOWN OF RADISSON RESPECTING CEMETERY RULES AND REGULATIONS

The Council of the Town of Radisson enacts as follows:

1. LAND DESCRIPTION

The following land is hereby declared to be a cemetery of the Town of Radisson and shall hereafter be known as the Radisson Cemetery:

"All that portion of the South-West Quarter of Section Twenty-nine (29, in Township Forty (40), in Range Ten (10), West of the Third Meridian, in the Province of Saskatchewan, Dominion of Canada, containing Five (5) acres, more or less, which may be more particularly described as follows:

or less, to a point in the said west boundary, thence southerly along the said west boundary a distance of Three hundred and thirty (330) feet, more or less, to the place of commencement. quarter section a distance of Three hundred and thirty (330) feet, to a point, thence westerly, parallel with the south Commencing at the south-west corner of said Quarter Section; thence Easterly a hundred and sixty (160) feet to a point; boundary, a distance of Six hundred and sixty (660) feet, more thence Northerly parallel with the west boundary of said

2. DEFINITIONS

- a) Vehicle includes any device in, upon or by which any person or property is or, may be, transported or drawn upon a roadway irrespective of the motive power, but shall not include an emergency vehicle;

- c) Roadway means a road or thoroughfare improved by gravel or other means, that is designed and intended for use by the public for the passage of vehicles;
- d) Emergency Vehicle means any vehicle owned and operated by the Radisson Fire Department, RCMP, or any provincially licensed ambulance company;
- Council means the Council of the Town of Radisson;

- 5. Vehicles in the Cemetery shall travel only on the roadways provided for that purpose and shall not travel at a greater speed rate than 10 kilometers per hour.
- 6. Children under fifteen years of age are not permitted within the Cemetery or it's buildings unless accompanied by proper persons to take care of them.

5. LOTS AND OWNERS OF LOTS

- 1. The Town Administrator shall make all sales of lots or plots in the Cemetery and shall receive all moneys resulting from the sale of such lots or plots, and for all interments made in the Cemetery, and shall forthwith turn over to the Town of Radisson, all such moneys received.

HEADSTONE MONUMENTS

- Headstone monuments in the cemetery will be permitted only, and in accordance with the following regulations:
 a) On Lots No. 1 to 70 inclusive the base of the headstone or grave
- marker shall not be placed closer than four (4) inches any side of a
- grave plot;
 b) No monument except a flat headstone or a flat headstone of a

 c) The cost of the foundations and the erecting of monuments or markers shall be the responsibility of the plot or grave owner or by persons Town Administrator. ordering same all specifics for such structures must be approved the
- d) Sloped monuments must be of marble or granite of a size of 12 inches wide, 18 inches long on single or 12 inches wide, 24 inches long on
- double, with a backslope no higher than 8 inches and a front slope no lower than 3 inches. e) Flat monuments must be of marble or granite, in the same sizes for
- single and double as for sloped monuments and in height 3 inches.
 f) Monuments must be set on a concrete base protruding 6 inches on all sides beyond the base of the stone but must be level with the ground.

8. CORRECTION OF ERRORS

The Town of Radisson or any official thereof shall not be responsible for any mistakes resulting from lack of precise or proper instructions regarding the grave space on a lot or plot where an interment is to be or has been made.

CARE OF LOTS/PLOTS

- 5. No fences, borders, railings, curbs, copings, trellises, walls, hedges or grave coverings of any kind shall be constructed or planted in or around lots or plots.
- coverings installed prior to the passing of this bylaw shall upon request of the owner, be removed by the Town of Radisson free of charge. 6. Those fences, borders, railings, curbs, copings, trellises, walls, hedges or grave
- 7. If, by reason of neglect or age, any fence, border, railing, wall, curbing, coping, hedge, trellis or grave covering of any kind that was erected, installed, or planted previous to the passing of this bylaw, becomes in an obvious state of disrepair, the Town of Radisson shall the owner, and if not removed within 30 days, the Town of Radisson shall remove the neglected or aged item.
- 9. The Town of Radisson shall have the authority to remove any and all items, become unsightly, dangerous, detrimental or diseased. 8. The Town of Radisson shall have the authority to remove all floral designs, flowers, and plants placed on a grave in order to complete landscaping maintenance flowers, weeds, shrubs, plants or herbage of any kind from the Cemetery if they

10. PLANTS AND SHRUBS

1. The Town of Radisson will undertake to maintain as may be practicable, the planting of trees and shrubs to preserve and maintain landscape features, but will not undertake to maintain individual plantings or containers of plants or flowers.

2. The Town of Radisson shall not be responsible for frozen plants or herbage of any kind, or for planting damaged by the elements, thieves, vandals or by other causes beyond control.

11. REPEALED

Bylaw No. 334 is hereby repealed.

12. COMING INTO FORCE

This Bylaw shall come into force and take effect on the date of the third reading and adoption by the Council of the Town of Radisson.
