

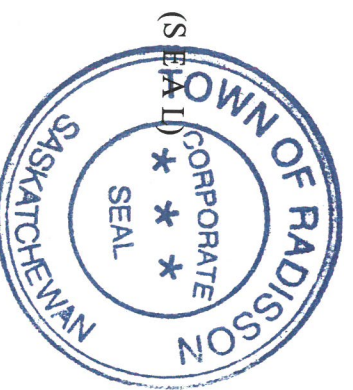


BYLAW No. 2021-01

A BYLAW TO AUTHORIZE A SPECIAL TAX FOR WASTE COLLECTION

The Council of the Town of Radisson, in the Province of Saskatchewan, enacts as follows:

1. A Special Tax be levied against all benefiting lands, as per Appendix "A", for the service of Contracted Waste Collection Services.
2. The placing of Contracted waste collection Services is hereby authorized effective **January 1, 2021** within the Town of Radisson Limits.
3. The estimated costs of the Waste and Recycle Collection Services for residential and commercial carts as per Appendix "A" of this Bylaw are as follows:
 - i) Residential Waste Collection - \$20.00 per month plus applicable taxes and fuel surcharge;
 - ii) Residential Recycle Collection - \$10.00 per month plus applicable taxes and fuel surcharge per month per parcel of land;
 - iii) Commercial Waste Collection -
 - 4-yard dumpster \$239.00 per month plus applicable taxes and fuel surcharge per month per parcel of land;
 - 6-yard dumpster \$280.00 per month plus applicable taxes and fuel surcharge per month per parcel of land;
4. The tax rate is \$ 20.00 per month per parcel of land to be levied against all owners/renters of land that are residential and commercial that require waste collection services and or \$ 20.00 per month per container based on number of containers required as per Appendix "A".
5. Any person who considers that an error or omission was made in the application or calculation of the special tax on his or her property may notify the municipality in writing by May 1, of current year requesting the council to review the application or calculation of the tax rate regarding the property in question.
6. The administrator will notify the persons, who have requested a review, of the time and date the council will meet to hear and review the requests.
7. The taxes that are levied will be added to the water & sewer roll as a special assessment against the property, when they become due and payable, and are recoverable in the same manner as municipal taxes.
8. That Bylaw No. 02-2019 is hereby repealed.
